## APPEAL FOR DONATION – FLOOD VICTIMS

Houses were badly damaged from the rising waters and swift currents, i.e; were ripped off roofs of homes, trees were uprooted, water and power lines were damaged, leaving the States Governments and the NGOs no choice but to temporarily relocate the flood victims to nearby schools. While some of us were blessed with good homes, many unfortunate ones suffered crippling losses from this calamity. Many businesses were also forced to close their operation. The total lost including infrastructures could run from hundreds to million Ringgit Malaysia.

The Incorporated Society of Planters ("ISP" or "Society") as a Non-Profit Organisation would like to give back to the public and can only achieve its goals with the assistance of generous donations from its members.
